1.3 The section of gutter guard noted in this photograph(Picture 1) is not properly installed and may allow debris to get into the drainage system. This could cause blockages,over flows and damage to either the gutter or an adjacent portion of the home. I recommend that a qualified contractor clean the gutters and re-install the gutter guard .As a maintenance item ,cleaning and inspecting the gutters should occur twice a year.


